As a voluntary initiative with over 800 signatories worldwide, PRME has become the largest organized relationship between the United Nations and management-related higher education institutions.

Hult International Business School has adopted a number of processes and practices to embed responsible and accountable management principles in our own governance and operations.

The school has adopted the following purpose statement: "We exist to create a better future for all by inspiring and challenging our community to make an impact that matters."

In addition to championing the embedding of Responsible Management Education in our curriculum and research, we are also championing in our own governance and operations.

Hult has adopted a target to be Net Zero in Scope 1 and 2 emissions by 2030 and in Scope 3 emissions by 2050. To achieve this goal, the school is currently investing in a staged program of investment to decarbonise heating across all campuses, and to switch all electricity supply contracts to 100% renewable. Hult calculates and publishes its carbon footprint across Scopes 1, 2 and 3 on an annual basis.

At Hult we champion Diversity, Equity, Inclusion and Belonging among our staff and among our student body.
