As a voluntary initiative with over 800 signatories worldwide, PRME has become the largest organized relationship between the United Nations and management-related higher education institutions.

Sustainability Management track in the MBA Programme

Sustainability Management track in the MBA Programme

The sustainability management track aims to build an understanding of sustainability in a cross-organizational context. In doing so, the track raises awareness of sustainability issues in various functional management domains while at the same time putting them in the societal context within which a business operates. Using business and policy-oriented case studies and building upon economic fundamentals, the track aims to approach sustainability from an **integrated perspective**.

This track exists of three mandatory courses

- Sustainable Management
- Sustainable Economics
- Sustainable Development

Sustainable Management (English). This course focuses on recognizing 'wicked' problems (poverty, inequality, biodiversity, pollution,...) and takes them into account when developing a sustainability policy; taking the international dimension into account when formulating a motivated advice on sustainability; Current trends: Circular economy, climate risks & nature-based solutions, Stakeholder management, Multi-actor collaboration; and ultimately: How can an organization create value by implementing a well-designed sustainability strategy.

Sustainable Economics (English). The course Sustainable Economics aims to support students in acquiring a deeper insight in why and how environmental and energy policy should be designed from a societal point of view and in what way businesses can deal with that policy. This course provides the students with a problem-solving framework for the analysis and remediation of externality problems such as pollution, energy and material use. Within a micro-economic framework, the role of consumers, producers and government is investigated.

Researchers at KU Leuven want to pave the way for a circular shoe industry in Flanders based on maintenance, repair and reuse. They are doing this together with LUCA School of Arts and several SMEs from the sector, among others, in a 'Living lab circular economy' funded by Flanders Innovation & Entrepreneurship (VLAIO).

The footwear industry - and especially that of sneakers - is trapped in a fast fashion system in which consumers are encouraged to regularly buy new shoes and throw away their old pair. That linear business model rapidly converts raw materials into waste, resulting in a huge environmental impact. Moreover, the role of shoe makers is deteriorating this way, as they cannot compete with cheap sneakers from low-income countries.

A shift to a more circular value chain for shoes is therefore imminent. But how can this take root in the Flemish economy? With its 'Living labs circular economy', VLAIO funds research projects that combat the throw-away mentality in the manufacturing industry.

A robust biodiversity in Flanders (CEDON)

As to the content it will be working on, the working group will put an emphasis on various themes which require an interdisciplinary or transdisciplinary approach. Subject matter could be the fortification of ecosystem services, such as carbon capture, by promoting biodiversity, the monetary valuation of species and the role of lists of species in good policy, the relationship between mental and physical well-being and nature and biodiversity, the harmonious pairing of food production in zones with biodiversity preservation, and the relation between biodiversity preservation and activities such as hunting and fishing.

KUleuven FEB aims to foster research with high societal impact and stimulates the cross-pollination between fundamental and applied, translational and policy-relevant research. Its connections beyond the corporate world to the political domain, social profit or not-for-profit sectors exemplify the drive to put its research to the use of the further development of economy and society. FEB hosts or is involved in several Policy Research Centres (e.g. Labour Market Monitoring, R&D Monitoring), which serve to bridge the worlds of science and policy by having an advisory responsibility to the Flemish Government. Use of Public transportation - Bikes: local social economy projects

At KULeuven FEB the use of **Pubic transportation** is encouraged.

Within Leuven, but also most in all other campuses, **going on foot** and **cycling** is **recommended**.

For distances up to 10-15 km a bike is usually the fastest, cheapest and healthiest option. The rental of bikes is on all campuses available. Most campuses work together with a **local social economy project**, where you can rent a decent bike for a low price (repairs and a good lock are mostly included). In some cities, you can even rent an electric bike to cover even greater distances or overcome steep slopes.

Everything in the center of Leuven, Brussels and Antwerp is within easy walking distance. For example, in all major cities special pedestrian signs have been developed to guide people around the city center efficiently. These signs contain often the names and description of sights in several languages. All major cities have a number of car-free pedestrian zones.

Carpooling: KU Leuven is connected to the Flemish carpool database. Staff and students can register for free.

Today more than 60% of KU Leuven employees come to work without a car: 33% of colleagues come on foot or by bike and 27% take public transportation. With this, KU Leuven serves as an example in terms of commuting for many other organizations.

At KULeuven Feb the use of **Pubic transportation** is encouraged.
