PRME engages business and management schools to ensure they provide future leaders with the skills needed to balance economic and sustainability goals, while drawing attention to the Sustainable Development Goals (SDGs) and aligning academic institutions with the work of the UN Global Compact. Driven by its mission to transform management education, PRME equips today's business students with the understanding and ability to deliver change tomorrow. As a voluntary initiative with over 800 signatories worldwide, PRME has become the largest organized relationship between the United Nations and management-related higher education institutions.

#### Economic of Race and Gender | Econ 69a

Economics 69a provides an introduction to the economics of race and gender with an emphasis on policy issues. We learn and use the tools of microeconomic analysis to understand how economists model individual decision-making, and to gain insight into how microeconomic theory can explain some of the changes experienced by women and minorities in the United States and other countries over the last century. Some of the questions we examine include: • Why do women typically specialize in household work in married households? How and why has this changed over time? • Do pronatalist policies work to increase fertility rates? • Do parental leave policies help or hurt women's careers? • Why do women earn less than men? • Why do African Americans earn less than whites? • What are the causes and consequences of 'missing women' in developing countries?
