As a voluntary initiative with over 800 signatories worldwide, PRME has become the largest organized relationship between the United Nations and management-related higher education institutions.



M.S in Business for Social Impact and Sustainability: Exploring sustainability and social entrepreneurship, this master's degree provides a holistic view of business for social impact, focused on applied research and real-world sustainable business solutions. Students apply concepts of responsibility and sustainability to the business field, as well as learn to approach challenges as potential innovation opportunities.

M.S. in Sustainable Fashion: Unique among college programs focusing on fashion, this degree prepares students for leadership roles, helping them transform the industry and develop creative strategies to support sustainability, social equity, and ethical practices within fashion. Students in the Sustainable Fashion program will learn the benefits of operating a business under a new paradigm, eschewing the former singular goal of profit for shareholders and replacing that with the need to serve a wide range of stakeholders. This program prepares graduates to understand the full range of business needs from supply chain to merchandising, to marketing messaging.

Both programs provide a solid social impact foundation for entrepreneurs and intrapreneurs interested in harnessing business models and financial tools for the Common Good.
