### **RME Accountability**

- The School recognises the critical role of RME Governance and Accountability in ensuring that Responsible Management Education (RME) is actively embedded across all areas, including research, education, operations, and partnerships.
- Plans to introduce a School-specific sustainability cross-cutting plan and strengthen the role of the Sustainability Committee to oversee all RME activities are expected to further enhance RME integration.
- The Dean actively champions and monitors the integration of Responsible Management Education, particularly given the latter's central role in the School's strategy.

- The Associate Deans for Research and Innovation and for Education and Student Experience have played an active role in integrating RME. This integration has significantly influenced our research priorities, including a strong focus on circular economy research, and has been a key driver in embedding RME throughout our education, particularly in the ongoing refresh of our programmes.
- The PRME Lead is directly responsible for overseeing reporting and sustainability initiatives, including our involvement with PRME Champions and the Global Business School Network (GBSN). The PRME Lead also chairs the School's Sustainability Committee, which manages sustainability in operations and the carbon action plan.
- In accordance with current University governance practices, the PRME Lead reports to the Associate Dean for Research and Innovation.
- The University is in the process of formulating a new strategy that will further streamline governance structures across the institution (see attached object).
- Looking ahead, the School plans to introduce a sustainability cross-cutting plan within the next year. This plan aims to further strengthen the role and membership of the Sustainability Committee to enhance RME integration across education, research, partnerships, and operations.


