The Principles for Responsible Management Education (PRME) is a United Nationssupported initiative founded in 2007 that aims to raise the profile of sustainability in their classrooms through Seven Principles focused on serving society and safeguarding our planet.

PRME engages business and management schools to ensure they provide future leaders with the skills needed to balance economic and sustainability goals, while drawing attention to the Sustainable Development Goals (SDGs) and aligning academic institutions with the work of the UN Global Compact. Driven by its mission to transform management education, PRME equips today's business students with the understanding and ability to deliver change tomorrow. As a voluntary initiative with over 800 signatories worldwide, PRME has become the largest organized relationship between the United Nations and management-related higher education institutions.



The PRME initiative was launched to nurture responsible leaders of the future. Never has this task been more important. Bold leadership and innovative thinking are needed to achieve the Sustainable Development Goals (SDGs).

In September 2015, all 193 Member States of the United Nations adopted a plan for achieving a better future for all – laying out a path over the next 15 years to end extreme poverty, fight inequality and injustice, and protect our planet. At the heart of Agenda 2030 are 17 Sustainable Development Goals (SDGs) and 169 related targets that address the most important economic, social, environmental and governance challenges of our time. The SDGs clearly define the world we want – applying to all nations and leaving no one behind. Successful implementation of the SDGs will require all players to champion this agenda; the role of higher education is critical to this.

RME Elements in Research

Groupe ESC Clermont incorporates responsible management education into its research endeavors through 3 different methods:

Dedicated Research Funding

Research Awards Program

ESC Clermont Business School supports its faculty through a strategic alignment of research activities with the School's broader objectives, including international collaborations and thematic research integration. The School's focus on incorporating faculty research into program modules enhances student engagement and deepens their understanding of contemporary business issues. This approach not only elevates the academic quality of the curriculum but also fosters a more mature and informed perspective among students regarding research's role in business development. CleRMa, ESC Clermont's joint research laboratory, plays a pivotal role in supporting faculty research through its extensive network and collaborative environment. With over 100 research faculty, including more than a third from ESC Clermont, CleRMa enhances the School's research capabilities by integrating academic efforts with both local public and private institutions. This synergy not only amplifies the impact of responsibility-related research but also fosters significant regional and international collaborations. ESC Clermont Business School incentivizes its faculty through a robust framework that includes research funding, performance bonuses, and dedicated support for highimpact research. Faculty members receive bonuses based on the quality and ranking of their publications, with additional rewards for meeting research targets over a two-year cycle. This structured support not only encourages faculty to engage in high-quality, responsibility-related research but also drives continuous improvement and innovation in the School's academic offerings.
