CUNEF Universidad integrates responsible management education into its degree programs through 6 different approaches:

#### Description of the business model with RME in all educational efforts

Our vision is underpinned by the ideas of RME and sustainable development, with the aim to continue to implement them systematically and transcendentally, shaping future leaders who are capable of driving positive social, environmental, and economic change. CUNEF ensures that its students are not only well-educated but also prepared to lead ethically and responsibly in their professional lives.

CUNEF ensures that its students are not only well-educated but also prepared to lead ethically and responsibly in their professional lives.

On curriculum level CUNEF Universidad offers courses with RME in the course-level learning goals, such as "Business Economics", "Business History" and "Ethics and Social Responsibility" courses in Bachelor in Business Administration and in Bachelor of Economics. "International Economics", "International Management and Strategy" and "Global Human Resource Management" courses in Master in International Business and Global Management. Please see the attached Object with more courses.

The students are given numerous opportunities of taking part in business competitions (e.g. **Business Case Competition**), simulations and round tables with participation of industry representatives (including alumni) to obtain necessary skills and experience.

CUNEF has 804 agreements with companies and institutions that provide *internship* opportunities for our students, where they learn and model socially responsible behaviour; a real-life experience, that will help them prepare for their future as responsible and socially conscious professionals. The employability rate at out University is 98%.

In that sense, concentrate our effort to increase the number of international partner universities (110 agreements at the moment), develop international joint programs with international partner universities, as well as facilitate international internships, and access to international employment opportunities; achieve international accreditations that endorse CUNEF as an excellent and prominent international university.

To provide students with a holistic education that makes them aware of the needs of our local community while offering them opportunities to make an impact, we encourage volunteering initiatives, fostering both solidarity values and social commitment. This volunteer work qualifies students when applying to participate on an international mobility program. More than 300 students participate every year in volunteer activities in cooperation with different NGOs and non-profit organisations. Some of these initiatives are:

**CARITAS**: Students raise money and collaborate with food banks.

Plantalo: An initiative to plant 1500 trees

**Fundación AED:** Tu móvil y tú. Teach elderly people to manage their mobile phones with confidence.

AECC (Asociación Española Contra el Cancer) Smoke free campus and antitabaco initiatives At our business school, sustainability, diversity, inclusiveness, and equity are fundamental pillars of our vision. Our practices and teachings promote long-term environmental stewardship and responsible resource management, preparing our students to lead in an era where ecological considerations are paramount. Diversity enriches our academic community by bringing together varied perspectives and experiences, fostering innovation, and enhancing the learning environment. Inclusiveness ensures that all individuals, regardless of background, feel valued and supported, creating a culture where everyone can thrive (Diversity and Inclusiveness initiatives – Buddy program, Multiconfessional space, Counselling). # Description of the Signatory Member's pedagogical approach, which involves RME in all degree program design and pedagogical innovations

In the context of responsible management education (RME), our focus is on integrating sustainability, ethics, and corporate social responsibility into business education. This pedagogical approach aims to equip students with the knowledge and skills to make responsible decisions in the business world, considering environmental, social, and ethical implications.

#### **Courses with RME in the course-level learning goals**

CUNEF continues the holistic involvement with PRME resulting in the integration of UN's ESG's into the curriculum in courses where sustainability is not explicit such as "Accounting Information Systems" (1st year of Bachelor in Business Administration and Bachelor in Economics), "Corporate Law" (1st year of Bachelor in Business Administration), "Economic History" (1st year of Bachelor in Economics) and "Business History" (1st year of Bachelor in Business Administration) and throughout all the programs offered at CUNEF. The Dean of the School of Business, Economics and Law, the Director of the School of Engineering and the Director of the Graduate and International Business School have introduced a sustainability oriented transversal competency throughout all the programs, where the goal is for learners to develop an ESG Sensitivity becoming aware of ESG issues, and where, and how to apply them.

#### Formative session for Faculty members on "Impactful Teaching"

The incorporation of new faculty at CUNEF Universidad, many of them recent PhDs, is increasing according to our academic offer and activity, along the expansion our institution is undergoing, therefore, to assure and maintain the highest quality of our faculty and cuttingedge teaching methods delivered to our learners, we have introduced new training and informative sessions for our faculty. The first informative session has taken place on November 21st - 22nd, 2023 on "Impactful Teaching" providing faculty with information on how to

generate insightful and persistent learner's experiences and how to manage with conflict within the classrooms effectively. At CUNEF Universidad we are always seeking the lifelong training of our faculty to assure quality and teaching effectiveness at all levels. Other informative and training sessions will be delivered and scheduled in the following months

#### Project-Based Learning (PBL) with a Focus on Social Impact

#### · Service-Learning and Community Engagement

Include service-learning components where students engage with communities to address real-world problems.

#### · Entrepreneurship, Sustainability and Leadership Programme

To educate future leaders for inclusive and complex work environments, CUNEF Universidad provides a Social Entrepreneurial Leadership Programme. This programme allows students to engage with social, educational, and environmental organizations through internships and volunteer activities. Students analyze organizational issues and develop practical solutions. In summer 2022, eight CUNEF students are participating in a four-week Entrepreneurship, Sustainability, and Leadership Programme in South Africa at Cape Town University and TSIBA Business School. The programme includes coursework on the 2030 Agenda and SDGs, along with volunteering and internships in local organizations and companies.

#### · Business Case Competition

The CUNEF Business Case Competition (BCC), now in its twelfth edition, aims to bridge the gap between academic knowledge and the business world by having students solve real corporate problems. The programme runs for about a month and a half (from March to April) and involves students working in teams to address challenges proposed by collaborating companies. Participants analyze the issues, devise solutions, and present their recommendations. Professors and company executives evaluate the submissions, selecting three finalist teams to present their proposals at a final event.

In the 2023-24 academic year, the 15th edition of the BCC was held in cooperation with Accenture and with participation of 130 CUNEF students presenting 22 projects.

#### **Partnerships with Responsible Organizations**

Internships with companies that have strong CSR programs, giving students hands-on experience in implementing and managing these initiatives.

#### · Banking Lab

CUNEF Universidad, founded in 1973 by the Spanish Banking Association (AEB), aims to develop future industry leaders to contribute to Spain's progress. Its strong ties to AEB provide an in-depth understanding of regulatory, compliance, and technological changes in the financial sector. In 2018, CUNEF, in collaboration with the AEB Foundation, established the "Banking Lab," a think tank that connects research professors, companies, and students to generate applied knowledge and develop practical projects for the banking industry.

The Banking Lab engages in organizing conferences, publishing discussion papers with policy implications, and disseminating results through media. It fosters collaboration with various banking-related institutions to co-finance and organize studies and events. Additionally, the AEB

Foundation offers scholarships based on merit, diversity, and non-discrimination to attract academically strong students from lower-income families to CUNEF Universidad for undergraduate or graduate studies.

The Banking Lab promotes collaboration with institutions and organisations linked to the banking world to co-finance and organise studies and events. Its initiatives include organisation of conferences/discussion seminars, discussion papers with policy implications, dissemination of results via the media, etc.

#### · Introduction to the ChatGPT software and its potential uses in education

Two introductory courses for our faculty on the new software and the implications of ChatGPT in terms of learner's competencies, teaching effectiveness and research methods were held. Two CUNEF faculty members experts in this field, have integrated this tool in their classes in the following courses: "Search, Processing and Use of Information" (1st year of Bachelor in Business Administration and Bachelor in Economics) and "Organisational Design and Behaviour" (2nd year of Bachelor in Business Administration).

At CUNEF Universidad we believe that collaborative work with other with business, government, civil society and academia can bring closer positive changes in different dimensions and layers, such as educational quality with enriched and responsibility conscious curriculum, sustainable campus, responsibility oriented research, students with global perspective and CSR awareness.

Acting: working collaboratively to enact change Advancing Research and Knowledge Some of the most recent research projects that CUNEF Universidad's researchers have participated in are detailed hereafter. 15 KITFEM Project CUNEF researchers participate in international projects like the KITFEM project (Knowledge and Innovation in, to and from Emerging Markets | K.I.T.F.E.M. Project | H2020 | CORDIS | European Commission). This research project, in which CUNEF was involved as an active leader, studied the management of knowledge and innovation in, to and from emerging markets, with special emphasis on its impacts on the EU. Involving 54 researchers, managers, and technological and administrative staff, KITFEM consisted of seven work packages to foster the interaction between the scientific community and other stakeholders, such as institutions, industries, businesses, and general civil society, to ensure popular interest and engagement in the researched topic. EM4FIT Project EM4FIT investigates entrepreneurship and related management practices from an interdisciplinary and multi-level angel as important variables in the interplay between individual, organization and institutional contexts within and between advanced and emerging markets. With the exchange among 16 partners (including CUNEF) from four continents and between the academic and non-academic sector, EM4FIT brings together knowledge from advanced as well as emerging markets to further understand how entrepreneurs and managers create successful businesses and foster growth.

#### **Promoting Social Responsibility and Ethical Leadership**

#### Volunteering

To provide students with a holistic education that makes them aware of the needs of our local community while offering them opportunities to make an impact, we encourage volunteering initiatives, fostering both solidarity values and social commitment. This volunteer work qualifies students when applying to participate on an international mobility program. More than 300 students participate every year in volunteer activities in cooperation with different NGOs and non-profit organisations. Some of these initiatives accomplished in 2023/2024 are:

- Continuous Volunteering with Fundación Oxiria: This involves teaching sessions for young people with disabilities at the Pirineos Campus. CUNEF students and Oxiria students engage in various activities together during in-person sessions. Over 190 students are enrolled, with around 50 participating per session.
- Inclusive Paddle Meet: The Volunteer Club organized this event with Fundación
  APROCOR, which focuses on improving the quality of life for people with disabilities.
  Held in September at the Wellsport Paddle Club, 23 CUNEF students and 11 APROCOR students participated.
- Food Drive: In November, a food drive was organized in collaboration with Fundación Pick-Up Solidaridad. Thanks to the help of 75 student volunteers, the foundation collected over 5,000 kilos of food for families in need in Vallecas.
- Christmas Campaign "No Child Without a Gift": During the first semester, the club collaborated with Fundación Ayuda en Red. Over 100 CUNEF students were able to give Christmas gifts to underprivileged children.

- Major Food Drive: During the second semester, a large-scale food drive was conducted for the Parish of San Juan de Dios in Vallecas and the Asociación Familiar Paellas Solidarias. More than 4 tons of food were collected with the participation of over 40 students.
- Roundtable with the Spanish Association Against Cancer: This event inspired four students deeply involved in the cause to implement an anti-smoking campaign at CUNEF.
- IV Solidarity Paddle Tournament María Valiente: More than 80 students and 20 brands participated, raising over 3,000 euros, which were donated entirely to ACOES, a foundation focused on fighting poverty in Honduras.
- Your Phone and You: This initiative involves training sessions to help seniors confidently use their mobile phones. With the collaboration of AEB, Fundación AEB, and Fundación Alicia y Guillermo, we expect the involvement of at least 100 students.
- X Edition of the Program "Your Finances, Your Future": Aimed at students aged 13-15, this program teaches prudent financial decision-making, personal budgeting, and the importance of savings. Twelve students volunteered, with a budget of 4,000 euros. The initiative is supported by AEB, Fundación AEB, and Junior Achievement.
- Volunteering Program with Cooperating Volunteers NGO: Fourteen students traveled to Mexico (Yucatán) to learn and assist in ecosystem conservation, the use of technology for the protection and maintenance of natural protected areas, responsible business practices, eco-friendly technologies, and corporate social responsibility promotion.
- Another Collaboration with Cooperating Volunteers NGO: A trip to India (Jaipur) involved 10 students who combined learning about culture and customs, visits to nature reserves, and collaboration with entrepreneurial women, a group of 5-20 women developing skills in sewing, crafts, and beauty.

#### Sustainability Club

- Participation in UN PRME Champions Meeting 2024-2025: Representatives from the Sustainability Club, including Juanjo Gutiérrez, Alfredo Rivela, Carlota Álvarez Peña, and Alejandro Bravo, took part in one of the panels. They shared their vision of sustainability at CUNEF University and its relationship with various university stakeholders, discussing the question 'Does sustainability in general influence your choice of university?'
- Alejandro Bravo's Role: We are very proud that Alejandro Bravo Sáez de Jáuregui has been serving as a United Nations PGS Ambassador for two years, promoting participation in PRME initiatives among students.
- Club Growth Challenge: Our goal is to increase the number of members in the Sustainability Club and engage more students in UN PRME initiatives, using examples like Alejandro Bravo's involvement as motivation.
- Climate Action Initiative: As part of a 'Climate Action' initiative, the club has set a goal to plant 1,500 trees in collaboration with Plantalo, starting with 200 trees in the first semester.
